Conditions for use - All persons using or modelling at this site must:

1. be MAAC members in good standing
2. be members of the Woodstock Radio Control Flying Club or an invited guest, and
3. agree to follow the MAAC Safety Code and all other site rules.

This event is open to the public.

The club will have a copy of these rules available at the site and make a copy available to all site users. All local (Township of East Zorra-Tavistock) rules are available by asking the event organizer.

No food and drinks are allowed in the building.

Vendors are not allowed to move the table without permission from the event organizer.

Maximum number of people in this facility is set to 250 people.

### **Normal operating procedures and Site safety rules**

This site allows the following modelling categories: Indoor swap meet open to the public

This site is for swap meet and static display only. No flying or operation of models on site is permitted.

1. No flammable liquids (engine fuel) or flammable substances or fire are allowed in the building.
2. No Electric Motor or Internal Combustion engine may be powered on or otherwise operated at the swap meet.
3. All power systems (gas, glow or electric) must be rendered inoperable by removing batteries, ignition leads or otherwise ensuring the model cannot inflict harm to any persons.
4. Batteries shall not be connected under any circumstances to electric powered models in the building– no exceptions. All fuel must be drained from internal combustion powered models.
5. Batteries shall not be connected to chargers or discharger at any time.
6. A small first aid kit must be available on site.

## Emergency or safety procedures

### 1. Site Emergency Procedures

- a. Emergency exits: the Northeast exterior door of the facilities or the Southeast entrance door of the building. (see diagram below)
- b. An AED is located just outside the main entrance door of the room.
- c. Fire extinguishers are located in the hallway outside the room.

2. There are no other risk mitigating strategies required at this modelling site.

3. The WRCFC organizer/executive will review these rules at least once a year.
